NOTICE INVITING TENDER

1. Sealed tender in two parts (Part-I is named as Technical Bid and Part-II being Price Bid) are invited by the Secretary of District Health & Family Welfare Samiti and CMOH of Cooch Behar District from eligible, bonafide, resourceful and experienced contractors for the under mentioned work as per specified terms and conditions. The Price Bid (Part-II) of Bidders who qualify in Technical Bid (Part-I) will only be opened.

2. The following papers should be enclosed with the application through speed post/registered post in their self letter head pad which would be addressed to the Secretary of District Health & Family Welfare Samiti and CMOH, Cooch Behar.
 - a) PAN Card.
 - b) VAT No. and current VAT return.
 - c) PTCC with current year Challan.
 - d) I.T. Return of 2010-11 financial year.
 - e) 100% credential in a similar nature of single work (with last financial year i.e. 2010-11).

The original copy of the above mentioned papers would be required at the time of collecting tender paper.

- 3 If permission is granted on the basis of above Para No.-(2) the bidders may purchase printed tender form together with price schedule of work from the CMOH office, Cooch Behar on payment of specified cost of respective tenders within the specified time.
- 4 Before submitting tenders, the intending tenders should thoroughly acquaint themselves with the proposed work by local inspection of site and make into consideration the difficulties. If any, like to be involved in execution of work, communication facilities, climate condition and adverse situation, availability of local labours, resources and rates prevailing in the locality. All this factors should be duly given weight age before quoting rates, as no claim, whatever will be entertained on any of these accounts afterwards.
- 5 The earnest money shall have to be deposited in the form of Bank draft/ Pay order/ Bankers' Cheque drawn in favour of "**District Health & Family Welfare Samiti**" A/c-1327321(UBI) payable at Cooch Behar. Bid without earnest money shall be summarily rejected. The Tender Committee reserves the right to assess the bidders' capacity and capability to perform the contract at any stage if required.
- 6 The bidder must not be blacklisted by any Government agency.
- 7 The bidder should quote their rates in figures as well as in words, percentage above/below/at per of the total amount of the price schedule of items with probable quantities.
- 8 The successful bidder must execute a formal agreement in prescribed form along with schedule in duplicate within 10 (ten) days from the date of issuance of work order failing which the work order will automatically be cancelled. He/ they will be responsible for executing the work as per direction and to the entire satisfaction of the Engineer-In-Charge and must complete the work within the stipulated time as per work order. Time is the essence of the contract.
- 9 The bidder will have to keep the offer open for ninety days on the date of opening of the tender. In case any bidder withdraws his/their offer within any validity period or fails to undertake the contract after acceptance of the tender the full earnest money will be forfeited.
- 10 There will be no price escalation in any reason.
- 11 The participating bidders may please note that an amount equal to 1 %(one percent) of the gross value of work will be deducted from the R.A. Bills/ Final bill on account of "The Building and other construction

workers (Regulation of Employment and conditions of Service) Act' 1996 and the building and other construction workers Welfare Cess Act' 1996" apart from other statutory deductions.

- 12 If the abovementioned offices happen to be closed on the date of receipt of application and/or the date of issue of the Bid Documents and/or the date of receipt of Bid Documents, the next working day (except Saturday) at the same time and venue shall be applicable for the said purpose.
- 13 The Tender Selection committee reserves the right to reject any or all tenders or to split up the works without assigning any reasons whatsoever and does not bind itself to accept the lowest tender.
